What is this type of insurance?

Comprehensive cover – You are covered for loss or damage caused by accidental damage, fire, theft and third party liability cover.

<p></p> <p></p> <p></p> <p></p>	<p>Whilst you drive or use your vehicle you will be covered for any third party property claim or claims arising out of one incident following:</p> <p>Property damage: Up to £20,000,000 where your vehicle is a private car not used for hire purposes; Up to £5,000,000 for any other vehicle or private car; Up to £1,000,000 in respect of any vehicle carrying hazardous goods; or Up to £1,000,000 for liability arising under the Road Traffic Act from an act of terrorism.</p> <p>Legal costs up to £1,000,000.</p> <p>Loss of or damage to your vehicle as shown in your schedule for accidental damage, fire and theft. We will either cover your costs to repair, pay a cash amount to replace or replace the lost or damaged item. ? **Medical expenses** for each person who is injured while they are in your vehicle as a result of an accident up to £500.

? **Personal belongings** up to £250 if lost or damaged in or on your vehicle caused by an accident, fire, theft or attempted theft.

? **Personal Accident** cover for the driver of any insured vehicle, if involved in an accident and within three months of that accident it is the only cause of death or injury. The most we will pay for death, loss of any limb or permanent loss of sight in one or both eyes is £10,000.

	Are there any restrictions on cover?
!	Endorsements may apply to your policy, these will be shown in your policy documents.
!	If a claim is made which you or anyone acting on your behalf knows is false, fraudulent, exaggerated, or provides false or stolen documents to support a claim we will not pay the claim and cover under this insurance will end.
	Where am I covered?
?	We will provide the cover shown on your schedule while you are using your vehicle in the UK or, if endorsed on the policy, in the European Union, Andorra, Iceland, Norway, Serbia or Switzerland (including Liechtenstein). Your permanent home must be in Great Britain, Northern Ireland, the Channel Islands or the Isle of Man and your visit to these countries must be temporary.
	What are my obligations?
-	<p>Your premium is based on the information you gave at the start of the insurance and when it is renewed. If you have failed to give us complete and accurate information, this could lead to us changing the terms of your policy, refusing your claim or the insurance not being valid.</p> <p>In the event of a claim or possible claim: You will need to pay the agreed excess as shown in your schedule. You must notify us within 48 hours of the incident happening.</p> <p>You must not admit to, negotiate on or refuse any claim unless you have our permission.</p> <p>You must tell us immediately about any changes to the information you have already provided. Please contact your broker if you are not sure if information is relevant. If you don't tell us about relevant changes, your insurance may not cover you fully, or at all.</p>
	When and how do I pay?
-	For full details of when and how you pay, you need to contact your broker directly.
	When does the cover start and end?
-	Your insurance is a 12 month contract which may be renewed each year. Renewal will be subject to the terms and conditions that apply at the time of renewal.
	The start date & time of your policy is stated in your policy schedule.
	How do I cancel the contract?
-	You may cancel the insurance at any time by informing your broker.
-	If you change your mind about this insurance, we will make a charge equal to the period of cover you have had.
